2016 PROJECT OF THE YEAR

The **SCAA** is proud to offer recognition to the finest exterior developments Alberta has to offer. Eight awards will be presented this year, four awards for projects in the North Region (north of Red Deer) and four awards for projects in the South Region (Includes Red Deer and Southern Alberta). One winner in each region will be chosen in each of the following categories:



- **Single-family Development less than \$500,000**
- **Single-family Development between \$500,000 & \$750,000**
- **Single-family Development over \$750,000**
- **Multi-family Development**
 - To be eligible in this category the development must be a:
 - ✓ Duplex home
 - ✓ Townhouse or Row House
 - ✓ Condominium or Apartment
 - ✓ Mixed-use Development
 - ✓ Hotel or Motel
 - ✓ Senior's Residence or other occupied specialty development
- **Commercial** - Unoccupied buildings (ie. strip mall, storefront)

Development Eligibility

All exteriors must be installed by an SCAA member in good standing and must be completed and paid in full by October 30, 2016. All projects must use a minimum of 70% of one or more of the following materials:

- Vinyl Siding
- Wood or Wood Composite Siding
- Fiber Cement Siding
- Metal Siding or Cladding Panels
- Other Specialty Siding Panels

Projects with more than 30% content of other products (ie. stucco or masonry) will not be considered.

Eligible Nominators

Nominations will be accepted from the following sources:

- Home Builders
- Architects
- SCAA Members (Contractors, Manufacturers, Suppliers or Affiliates)

All nominators are urged to put forward their best exteriors for 2016. The projects should display excellence in workmanship and attention to details. Nominators can submit as many projects as they desire.

Contest Judging

Judging of all nominations will be completed by a panel selected by the SCAA Board of Directors. Judges reserve the right to request on-site access to any and all finalist projects in order to determine a winner. Judges will contact the nominator if it is felt the project should have been submitted in another category. SCAA members will not be allowed to judge developments they have a known interest in. All decisions are final.

Award Winners

All award winners will be invited to attend an SCAA meeting or event, where they will be presented with their 2016 Project of the Year Award.

SUBMIT A NOMINATION

1. Complete the attached **nomination form** in full;
2. Provide at least **two quality exterior photos** of the completed project. These photos will be used by the Judges in making their preliminary selections. If a site visit is required for the final decision, the nominator will be contacted to make the arrangements.
